Dear Producers and Millers

SUBJECT: WHITE MAIZE GRAIN FLOOR PRICE – 15 - 28 MAY 2024

1. Clause 2.2 of the White Maize Marketing Agreement for the 2023 marketing clearly states that “should the calculated SAFEX Spot Price- Weighted Average for the previous fortnight period be higher than the Staggered Floor Price, then the SAFEX- Fortnight Weighted Average Price formula shall be implemented”.
2. As per the attached calculation, the **SAFEX- Fortnight Weighted Average Floor Price** for the previous two weeks (**30 April to 13 May 2024**) of **N\$7,087.51 per ton** is higher than the **SAFEX- Staggered Floor Price** of **N\$5,918.03 per ton** for the period **15 – 28 May 2024** by **N\$1,169.47 per ton** or 17%.
3. Therefore, the **SAFEX -Fortnight Weighted Average Floor Price** of **N\$7,087.51 per ton** shall be the applicable floor price for White Maize grade 1 (WM1) bought or delivered within the fortnight of **15 – 28 May 2024**.
4. The NAB will continue monitoring the SAFEX- Fortnight Weighted Average Floor Price for the upcoming two weeks and notify the industry accordingly, should this price be lower than the SAFEX – Fortnight Weighted Average Floor Price for the same period.
5. Furthermore, please take note that, both the processor and producer levy of 1.4% should be calculated based on the **Subtotal - SAFEX-Fortnight Weighted Average Floor Price** of **N\$6,841.22** which excludes the import levy differential, and hence the producer levy to be deducted from the producer's price by all processors is **N\$95.78** per ton.
6. Please take note that, this floor price is subject to changes every fortnight and hence not fixed for the entire marketing season.
